



**Flaherty & Crumrine Preferred Income Opportunity Fund (the “Fund”)**

**Cusip: 33848E106**

NYSE Symbol: PFO

On October 27, 2008, the Fund declared a common stock distribution of \$0.055 per share payable November 12, 2008, to shareholders of record on November 7, 2008. Fund management estimates that approximately 94% of the distribution will be made out of the Fund’s net investment income (or \$0.0517), but approximately 6% of the distribution (or \$0.0033) could instead consist of non-taxable return of capital. A “return of capital” represents a return of a shareholder’s original investment in the Fund’s shares, and should not be confused with a dividend yield or capital gains. To the extent shareholders receive a return of capital they will be required to adjust their cost basis in the Fund’s shares accordingly.

The final determination of the tax characteristics of all 2008 calendar year distributions will not be made until after December 31, 2008. In January 2009, Form 1099 DIV will be sent to shareholders that will state the aggregate amount and tax characterization of distributions for the 2008 calendar year.

Shareholders should consult their tax advisor with questions regarding the taxation of distributions, and any necessary adjustments to their cost basis in the Fund’s shares.
