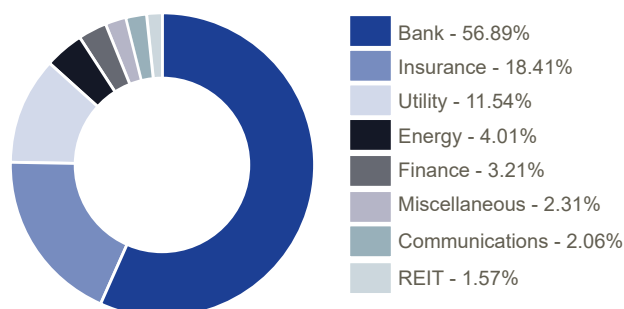

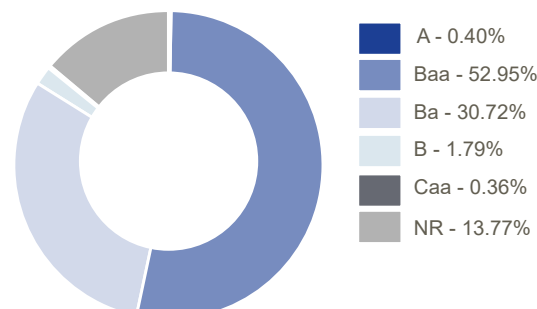

Credit Quality as of 5.31.26



Credit quality, as rated by Moody's, is an assessment of the credit worthiness of an issuer of a security.
