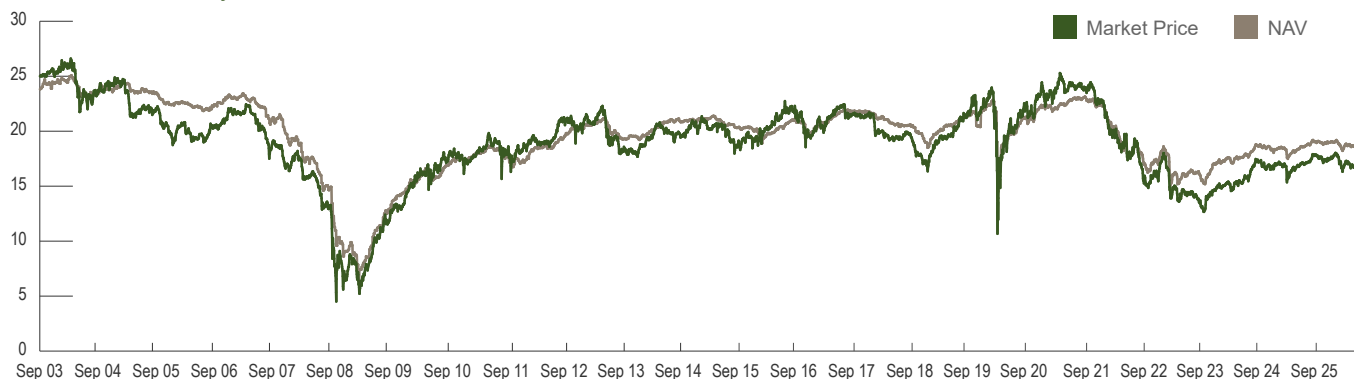

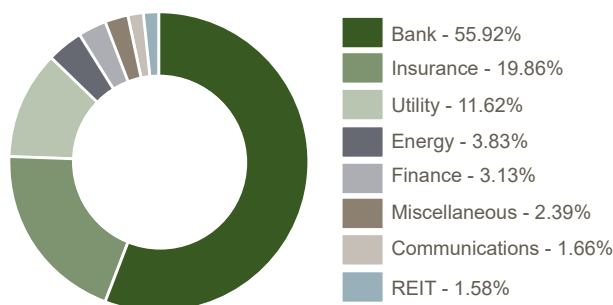

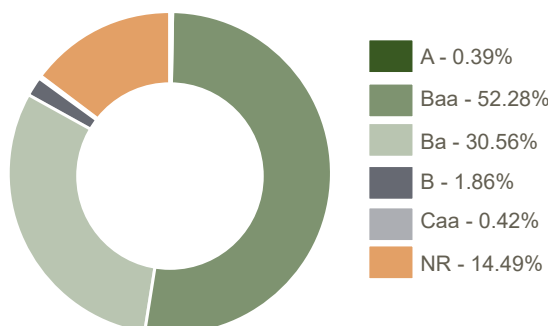

Credit Quality as of 7.31.26



Credit quality, as rated by Moody's, is an assessment of the credit worthiness of an issuer of a security. Aaa is the highest rating; the obligor's capacity to meet its financial commitments is strong. As ratings decrease, the obligor is considered more speculative by market participants.
